76821	Internal – Payment Verification - Payment column header states original submission date/time; update to Submission date/time	the payment date/time displayed is the most recent but the column is labelled original submission date/time. It was confirmed that the Submission Date/Time provided is the most recent (ex: if the application was resubmitted after correction, it will show the more recent submission date/time). The column header has been updated from Original Submission Date/Time to just Submission Date/Time to accurately reflect what that date represents.

6886	Asbestos - NESHAP rule	<p>When I tried to save I forgot to put in prior use description and it flagged it. Then it showed me a business rule validation that said: “The building must be thoroughly inspected for ACM prior to any renovation or demolition. If the amount of friable ACM that will be removed is more than 260 linear feet, 160 square feet or 35 cubic feet, the project falls under the federal NESHAP regulations. This requires that a notification be postmarked or hand delivered to DEP and EPA at least 10 WORKING DAYS prior to the start of the project.”</p> <p>1. This statement is incorrect. Notification is always required for all demolitions of a facility. The statement leads people to believe that it is not required for demolitions.</p> <p>Update Business Rule validation message for NESHAP to read as follows: A project that includes the demolition of any defined “facility” is regulated by NESHAP. The building must be thoroughly inspected for ACM prior to any renovation or demolition. If the amount of friable ACM that will be removed is more than 260 linear feet, 160 square feet or 35 cubic feet, the project falls under the federal NESHAP regulations. This requires that a notification be submitted to DEP at least 10 WORKING DAYS prior to the start of the project. Working Days = Monday through Friday and includes holidays that fall on any of the days Monday through Friday.</p>

Please contact the appropriate DEP regional office or local government agency’ should not be displayed when user clicks ‘No’ to Will alternative methods to any of the applicable regulations be used?</p> <p>It should only appear if YES is answered.</p>
