49670	Transition to Greenport/Keystone	Greenport will be upgrading to utilize Keystone ID for login. This is not a change to e-permitting; but users will need to interact with Greenport to update their login information.
56345	External - Dual User/Submitter and Reviewer roles for external users	The Staging environment is now available to users outside of DEP as a 'playground' or training area. CCD users that would be training and testing both as submitters and reviewers will need to come through Greenport using only one login and password. This required a landing page for those users to select which area they wanted to work in – Internal Review or External Submission

51039	Public Public Download All link re-added	On the public view page, the link to 'Download All Attachments' had been turned off because it was not properly filtering out confidential documents. This is resolved and the link is once again available to allow easy download of all attachments for an application.
51087	Internal - New Client Registration review needs to show attached signature details	The New Client Registration review was showing all entered data but not anything associated or attached to the signature area. All the entered information, including attachments now display in the New Client Registration review.
54819	Internal – Dashboard – New Status Verifying Payment	If a lead reviewer is assigned to an AUTH and then that AUTH is returned for correction, they are still the lead reviewer; and as such, the application should remain on their dashboard in the grid 'applications where I am assigned lead reviewer'. Even if a payment fails on correction – they are still the lead reviewer and are assigned as the lead reviewer. The application would now also show up on the pending payments grid for the merchant admin to take care of (and the lead reviewer may not have access to that grid); but it needs to stay on their lead reviewer grid until a final determination is made. Similarly, if a person has a task assigned to them for an AUTH; that task is still assigned to them even if there is an issue with payment during correction. It should not fall off of their grid of 'tasks assigned to me'

Today, when a correction is re-submitted; the status on the dashboard changes to "Correction Re-submitted". We need to provide more information to the lead reviewer when there is a payment problem.

**New change:**

If a Correction has been re-submitted but has a payment that needs verified - the status should be "Verifying Payment".  
If the Payment on that correction re-submission is not found or declined, the Status would change back to "Correction Required"

If the Payment on that correction is accepted, the Status would change to "Correction Re-submitted"

(note that new submissions will not appear on any dashboard-aside from payment verification - until the initial payment issue is resolved - this functionality is working and there is no requested change)

This is something that needs to be done system wide for all program areas in regard to items sent and returned from correction. As such, this would not impact the 'new client registration' grid or the grid in Oil & Gas which is for clerical staff since those would never have listed an application that has been returned for correction. This would impact any grid on the internal side which may display an AUTH that has been returned for correction.
